We stand behind our trailers and are committed to your complete satisfaction.

----- FIVE YEAR LIMITED WARRANTY -----

Manley Metalworks, LLC warrants to the Original Purchaser named on the Certificate of Origin that each Manley Trailers operated under normal use and conditions in the continental United States will be free from defects in materials and workmanship for a period of FIVE YEARS except herein limited, from the date of the first purchase provided all stated conditions and exclusions are met and satisfied. The obligation of this warranty is limited to repairing or replacing, any part (or parts) in the overall frame structure which, in the opinion of MANLEY METALWORKS, LLC, is defective in material or workmanship under normal use and service during the FIVE YEAR warranty period of original ownership of your Manley Trailers. This warranty is non-transferrable. Warranty will not extend to any unauthorized modifications made to the manufacturer's original trailer or its components parts. Warranty shall be invalid if trailer is used for commercial hauling or rented.

### WARRANTY CARD MUST BE RETURNED

Federal Law requires documentation of your purchase. You will find your warranty card at the bottom of your Certificate of Origin (title) you received from your Dealer. Please read over our warranty with your dealer. BE AWARE!! This Limited Warranty shall be NULL and VOID and without effect, unless an AUTHORIZED MANLEY TRAILERS DEALER and YOU (purchaser), sign and date the completed warranty card attached to the bottom of your "CERTIFICATE OF ORGIN" (title), and return it within 10 days of purchase to MANLEY METALWORKS, LLC dba MANLEY TRAILERS 169 Industrial Blvd Eatonton, Ga. 31024.

### 5 YEAR LIMITED STRUCTURE WARRANTY

Manley Metalworks, LLC certifies to the original purchaser under normal use of Manley Trailers a Structural Limited Warranty for FIVE YEARS from the date of purchase, against defects in material and workmanship of the trailer's structural main frame, consisting of the bottom rails, cross-members, side posts, roof, rails and bows, tongue and the sub-frame, excluding the floorboards and running gear.

### ONE YEAR LIMITED WARRANTY

Manley Metalworks, LLC offers a Limited Warranty, for a ONE YEAR period to original purchaser, against defects in material and workmanship under normal use of Manley Trailers, subject to the requirements, exclusions and limitations stated below: Doors, ramps, lights, plumbing, stone guard, wood deck, floor covering, improper application of paint or undercoat, sealants, locks, couplers, jacks, hinges, wiring, electrical and related hardware.

Manley Metalworks, LLC warrants the paint finish on Manley Trailers to be consistent with industry standards for ONE YEAR after date of original purchase, with the exception of normal use limitations set forth below and of deterioration due to use or exposure, such as chipping, scratching, fading, cracks in caulk seams, road grime including tar, salt, magnesium or calcium chloride, damage by animals or pressure washing. Paint repairs are limited to spot repairs and blending consistent with standards in the trailer industry. Any repainting due to welding or work related to warranty is not covered by this warranty.

#### EXCLUDED FROM COVERAGE BY THIS LIMITED WARRANTY

This Express Limited Warranty excludes any claims related to items purchased and installed by Manley Metalworks, LLC dba Manley Trailers which are warranted by their respective manufacturer, including but not limited to, awnings, air conditioners, tires, rims, axels, axel components including but not implied limitations, tow in and tow out on axel, camber on axel; springs and suspension components; couplers and jacks, brake components; and any other items purchased and installed by Manley Metalworks, LLC. Any claims related to components must be presented to their respective Manufacturer for adjustments.

Subject to the other terms of this Limited Warranty, Manley Metalworks, LLC, warrants proper installation of the above listed items. Damage, malfunction or wear caused by misuse or abuse including, but not limited to, overloading gross vehicle weight ratings as shown in the vehicle identification label (VIN) , improper loading, negligence, alterations without prior written consent from Manley Trailers, accidents, riots, war, acts of nature or God, use of incorrect or altered hitch ball or improper latching, loose or improper torqued lug nuts, screws, or bolts( maintaining proper tightness is owner's responsibility) or failure to provide reasonable and necessary repairs or maintenance.

Warrantor expressly disclaims any responsibility or damage to the appearance of items located on the trailer where damage is due to normal use and exposure to the elements. Manley Metalworks, LLC reserves the right to test individual parts for magnesium and calcium chloride exposure; these materials are extremely corrosive to all metals and damages due to exposure are not covered by this warranty.

Manley Metalworks, LLC, expressly excludes from this Limited Warranty replacement and work performed or options installed by others; loss of time, inconvenience. Lodging expense, loss of use of trailer, rental of trailer substitute equipment, loss revenue, or other commercial loss; freight or towing vehicle wear or cost to repair facility; repairs made in any manner other than that approved by Manley Metalworks, LLC manufacturer of Manley Trailers.

Manley Trailers, manufactured by Manley Metalworks, LLC, covered by this Limited Warranty was designed to be towed by a vehicle with up to 1-ton capacity and this Limited Warranty does NOT cover any use of the trailer that exceeds tow vehicle manufacturer's specific limitations.

#### PRIOR WRITTEN AUTHORIZATION AND RETURN OF DEFECTIVE PART(S) REQUIRED

All warranty repairs are to be referred to the dealer where your Manley Trailers purchase was made. Proper arrangements must be made and written pre-authorization is required for warranty work. No reimbursement will be made to any Dealer or Owner for repairs on Manley Trailers without prior written consent of Manley Metalworks, LLC. Manley Metalworks, LLC will repair or replace, at its option, without charge, any part(s) found to be defective due to defects in material or manufacturing when part(s) is sent prepaid freight to Manley Metalworks, LLC dba Manley Trailers at 169 Industrial Blvd Eatonton, Ga. 31024 under this Limited Warranty.

## ALL OTHER PRODUCTS EXCLUDED

This Limited Warranty applies exclusively to Manley Trailers manufactured by Manley Metalworks, LLC. Any other products manufactured by Manley Metalworks, LLC are specifically excluded from this warranty. Authorized repairs do not extend the terms of this Limited Warranty.

## DESIGN CHANGES

Manley Metalworks, LLC, dba Manley Trailers reserves the right to alter or modify the design of its manufactured products from time to time without notice and with no obligation to make corresponding alterations or modifications in its products previously manufactured and sold.

## WARRANTY NON TRANSFERABLE

Manley Metalworks, LLC dba Manley Trailers Limited Warranty is NOT Assignable or transferable; Warranty extends only to the original purchaser and ends when the original purchaser sells or transfers the trailer.

## AGREED VENUE

MANLEY METALWORKS, LLC dba MANLEY TRAILERS WILL MAKE EVERY ATTEMPT TO REPAIR ANY MANLEY TRAILER COVERED UNDER THE TERMS OF THIS LIMITED WARRANTY UNDER PURSUANT TO THE LAWS OF THE STATE OF GEORGIA. THE PURCHASER OF A MANLEY METALWORKS, LLC, AND MANLEY TRAILERS AGREES THAT IN THE EVENT OF ANY DISPUTE GIVING RISE TO LITIGATION WILL BE FILED WITH THE COURT SYSTEM OF THE STATE OF GEORGIA, COUNTY OF PUTNAM.

## LIMITATIONS

THE DURATION OF ALL IMPLIED WARRANTIES, INCLUDING BUT NOT LIMITED TO THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE, ARE LIMITED TO THE DURATION OF THIS WARRANTY. MANLEY METALWORKS, LLC RESPONSIBILITY UNDER THIS LIMITED WARRANTY SHALL BE TO REPAIR OR REPLACEMENT OF PART(S) AT THE MANLEY TRAILERS MANUFACTURER, OR FOR A REASONABLE ALLOWANCE, AT ANOTHER PLACE APPROVED IN WRITING BY MANLEY METALWORKS, LLC dba MANLEY TRAILERS. IF SUCH WARRANTY FAILS BECAUSE ATTEMPT AT REPAIR ARE NOT COMPLETED WITHIN A REASONABLE TIME, OR IT FAILS FOR ANY OTHER REASON, ANY DAMAGES ARE LIMITED TO THE LESSER OF EITHER THE COST OF NEEDED REPAIRS OR REDUCTION IN THE MARKET VALUE OF THE TRAILER CAUSED BY LACK OF REPAIRS. THE BUYER OF A MANLEY TRAILER AGREES TO IDEMNIFY AND HOLD HARMLESS MANLEY METALWORKS, LLC FOR ALL CLAIMS BY THIRD PARTIES IN EXCESS OF THESE LIMITATIONS.
